Marjorie,

I have reviewed the subject EA and supporting documents for Swatch Group U.S. and agree with the conclusions and that a Finding of No Significant Impact is appropriate.

My review of the radioactive waste manifest shipping paper did raise one concern that has been resolved through discussion with Mr. Steve King of Radiation Physics, Inc. The manifest indicates 0.1 mCi of Radium-226 was disposed of along with the NRC licensed waste. Mr. King indicated that Swatch Group inadvertently received watches for repair that contained radium dials and that all radium has now been properly disposed of and that they will not be working with radium dials in the future. He also confirmed his surveys indicate no radium contamination exists in the facility.
