Dear Mr. Masciangelo:

This is in reference to your application and letter dated December 22, 2004 requesting to amend Nuclear Regulatory Commission License No. 37-30750-01. In order to continue our review, we need the following additional information:

1. Your application does not contain the information needed to support your request for fixed gauge activities. Please resubmit your application using the guidance in NUREG-1556, Volume 4, "Consolidated Guidance About Materials Licensees: Program-Specific Guidance About Fixed Gauges" (enclosed). The checklist in Appendix B in NUREG-1556, Volume 4 contains procedures that are acceptable to the NRC and may be used to submit your response. Your application provided verbiage that differs from the current guidance and also provides information not required to be submitted at this time. Please photocopy Appendices A and B, checkmark the appropriate boxes, and attach your procedure titled: "Bolting and Unbolting."
2. Your application indicates that you possess Berthold Model No. 7440 fixed gauges. In order to assure that Item 7 of your license correctly identifies the sealed source model numbers associated with these gauges, please indicate if these gauges were manufactured by Berthold Systems, Inc. or by Berthold Technologies, Inc. Berthold Systems no longer manufactures these devices and is no longer in business. Berthold Technologies is a viable company that manufactures these devices, but with different sealed source models. If you know the Sealed Source and Device Registration number, you may provide that number.
3. In your letter dated April 5, 2004, you indicated that your company was emerging out of bankruptcy. Please describe the current financial situation of your company.
4. Please provide the Radiation Safety Officer's business fax and email address for our records.
