Dear Dr. Greenblatt:

This is in reference to your letter dated January 13, 2005 requesting to renew Nuclear Regulatory Commission License No. 29-28428-01. In order to continue our review, we need the following additional information:

1. Please confirm that David V. Habif, Jr., M.D. still performs the duties of an authorized user until such time as the training and experience of Adrienne M. Greenblatt, M.D. and Howard Kirzner, M.D. are resolved.
2. On March 5, 2002, you requested an amendment to the NRC license to add Dr. Greenblatt as an authorized user. This request was withdrawn at your request by a letter dated May 2, 2002, in which you stated that documentation showing continuing experience in nuclear medicine within the last seven years could not be provided.

Two letters dated December 13, 2004, signed, respectively, by Drs. Greenblatt and Kirzner state that both have received Continuing Medical Education (CME) to maintain their medical licenses. CME does not necessarily provide continuing education or experience for the practice of procedures in nuclear medicine. Documentation as to the topics covered and the amount of time spent in training would need to be provided for our review.

Your response to our Request for Additional Information did not contain the information needed to approve Drs. Greenblatt and Kirzner as authorized users. The license you provide is from the State of New Jersey. The State of New Jersey is not an Agreement State and authorizes the use of cyclotron- and accelerator-produced radioactive materials. As such, it does not meet the specifications of 10 CFR 35.290(b) or 35.920.

The Certificates of Achievement from EduMed for Dr. Greenblatt do not give a sufficient breakdown of the topics covered and the time covered to make a proper assessment as to whether they are sufficient to meet the continuing training requirements for nuclear medicine.

If you can not show continuing experience or education in the practice of nuclear medicine or cardiology between 1983 and 2002 as evidenced by your May 2, 2002 letter then Dr. Greenblatt must meet the requirements of 10 CFR 35.290(c). The same requirements apply for Dr. Kirzner. The preceptor statements found in NRC Form 313A must be completed and signed by an authorized user.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site. Interested members of the public may obtain copies of the referenced documents for review and/or copying by contacting the NRC Public Document Room pending resumption of public access to ADAMS.
