The Environmental Assessment for this action was published on February 4, 2005 in the Federal Register, Volume 70, Number 23. All facilities previously used for licensed activities may be released for unrestricted use.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site.
