Dear Mr. Hannig:

This is in reference to your application dated December 1, 2004 requesting to renew Nuclear Regulatory Commission License No. 29-23394-01. In order to continue our review, we need the following additional information:

1. Please list all authorized users who will be installing and servicing the gauges. Include the experience and specific training they received to be qualified to install and service the gauges requested.
2. Verify that you will have an operable and calibrated survey instrument available to meet the requirements of 10 CFR 20.1501.
3. Your application did not address personnel monitoring. Confirm that all authorized users will have personnel monitoring devices.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site. Interested members of the public may obtain copies of the referenced documents for review and/or copying by contacting the NRC Public Document Room pending resumption of public access to ADAMS.
