Dear Mr. Budney:

This is in reference to your application dated February 15, 2005 requesting to renew Nuclear Regulatory Commission License No. STB-1530. In order to continue our review, we need the following additional information:

The Decommissioning Funding Plan (DFP) on file for this license was drafted in March 1997. The DFP needs to be reviewed to ensure that the description of facilities and work practices is accurate. The DFP currently states that waste filings are stored in a locked room at the rear of the facility. In February 1998 the license was amended for a waste storage trailer outside, behind the main building. For waste disposal the current DFP states drums of waste filings will be transferred to Allied Signal at a minimal cost. During an inspection of your facility by this office in November 1999, Budney officials stated waste would be transported to an authorized disposal site. The cost estimates of the DFP also need to be updated to reflect the current costs associated with the surveying, clean up and decommissioning of the facility including the disposal of waste. Please submit a revised DFP. Once the revised DFP is reviewed and approved the dollar amount of financial assurance may need adjustment.
