Dear Dr. Bixler:

This is in reference to your application dated February 28, 2005 requesting to renew Nuclear Regulatory Commission License No. 37-17938-01. In order to continue our review, we need the following additional information:

1. The company name on the license has changed. Please provide a complete description of the transaction (transfer of stocks or assets, or merger). Include the name and telephone number of a licensee contact who NRC may contact if more information is needed.
2. Describe any changes in the organization that relate to the licensed program.
3. Confirm that the transferee will abide by all constraints, conditions, requirements and commitments of the transferor.
4. Describe all rooms being utilized for licensed material within Building 53. Include a description of the area(s) assigned for the receipt, storage, preparation and measurement of radioactive materials. Submit a diagram showing the locations of shielding, the proximity of radiation sources to unrestricted areas, and other items related to radiation safety. Where licensed material may become airborne, the diagrams should contain schematic descriptions of the ventilation systems, with pertinent airflow rates, pressures, filtration equipment, and monitoring systems. Diagrams should be drawn to a specified scale, or dimension should be indicated.

Current NRC regulations and guidance are available at the NRC Web sites listed below or by contacting the Government Printing Office (GPO) toll-free at 1-888-293-6498. The GPO is open from 7:00 a.m. to 9:00 p.m. EST, Monday through Friday (except Federal holidays).
