

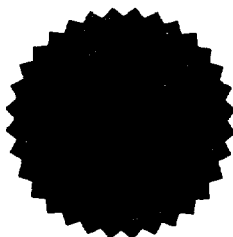

FIRST: The name of the corporation is Synaptic Pharmaceutical Corporation. The date of filing of its original Certificate of Incorporation was January 16, 1987 under the name "Neurogenetic Corp."

SECOND: The Certificate of Incorporation of Synaptic Pharmaceutical Corporation is hereby amended by deleting Article FIRST thereof in its entirety and inserting in lieu thereof a new Article FIRST reading in its entirety as follows:

"FIRST: The name of the corporation is Lundbeck Research USA, Inc. (hereinafter called the "Corporation")."
