Lee for materials permitted under 10 CFR 35.100 and 35.200, please provide written certification, signed by a preceptor physician authorized user, that the training and experience requirements of 10 CFR 35.290 has been satisfactorily completed and that a level of competency sufficient to function independently as an authorized user for the medical uses authorized has been achieved.
