I am writing to request an amendment to Princeton University's broad license, to delete items 6I and 6Q for, respectively, a 300 mCi Cs-137 sealed source (Isotope Products Laboratory, Capsule Type 225) and a 500 mCi Am-241 sealed source (Isotope Products Laboratory, Capsule Type SK527). The Cs-137 source was shipped for disposal via RACE, LLC on December 10, 2004, and the Am-241 source was shipped for disposal through the LANL Off-Site Recovery Program on March 24, 2005. We have no need for similar sealed sources and accordingly are requesting that these two items be removed from the University's broad license.
