
Dear Licensing Assistance Team,

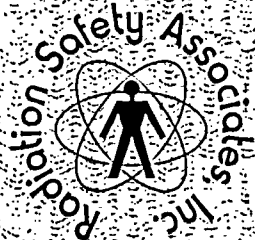
