Dear Ms. Doudy:

This is in reference to your letter dated March 17, 2005 requesting to amend Nuclear Regulatory Commission License No. 09-30973-01. In order to continue our review, we need the following additional information:

1. Your letter should have been signed by a management representative rather than Margaret Doudy, Paralegal. Please submit a letter signed by a management representative indicating that management has reviewed the application and concurs in the statements and representations contained therein. Note also that a management representative should sign all future correspondence that requests a change in your license. Alternatively, management may sign a letter granting Ms. Doudy the authority to request changes in the license.
2. In your letter you request that Michael Meredith replace your current Radiation Safety Officer, Roy Kenton. We have reviewed Mr. Meredith's qualifications and have found that more information regarding his experience with radioactive materials is needed. From the telephone discussion with Ms. Doudy on May 2, 2005, it is our understanding that Mr. Meredith is named on a State of Florida license for the same activities as listed on the NRC license. Please provide a copy of the State of Florida license for our review.
