In support of your request to authorize Dr. Rivas for materials permitted under 10 CFR 35.100 and 35.200, please provide written certification, signed by a preceptor physician authorized user, that Dr. Rivas has met the training and experience as specified in 10 CFR 35.290 (c)(1) and that he has achieved a level of competency sufficient to function independently as an authorized user for the medical uses authorized has been achieved. You may use the enclosed Form 313A to document the aforementioned. (Please note that the Certification Council of Nuclear Cardiology is not an approved board as of this time).
