RE: FREEDOM OF INFORMATION ACT REQUEST

To Whom It May Concern:

Pursuant to the provisions found under the Freedom of Information Act, 5 U.S.C. Section 552, as amended, the American Federation of Government Employees (AFGE), specifically the undersigned, hereby requests a copy of the following materials which concern the U.S. Department of Agriculture (NRC) and the National Treasury Employees Union (NTEU):

1. A copy of the most recent collective bargaining unit agreement(s), between the NRC and NTEU, for both professional and non-professional employees;
2. The total number of employees in the NRC bargaining unit, including their names and job titles and grades, by location, at each site;
3. A copy of all correspondence between NRC and NTEU in the last six months, which relate to any existing agreements and their renegotiation;
4. Organizational charts of each location depicting all employees described above including their names, job titles and grades;
5. A copy of the employee handbook, or any other administrative document regulating personnel policies or practices;
6. Number of administrative grievances filed in the past eighteen months, by NTEU
7. Number of MSPB appeals filed in the past eighteen months, by NTEU
8. Number of EEO complaints filed in the past eighteen months, by NTEU

In the event that you determine that some or any part of the requested information/material is exempt from disclosure, I request, pursuant to the Act, that you provide me with the exemption(s) you maintain covers the material you are not releasing. In addition, I shall expect release of all reasonable segregable documents not exempt from disclosure.


