We have discussed the issue of updating the decommissioning funding plan (DFP) for Ledoux & Co. Refer to my letter to you dated April 6, 2005 on this matter. Please note that if the dollar amount (currently \$56,000) of your DFP changes, you will need to amend other financial documentation as well. This would include:

Certification of Financial Assurance  
Letter of Credit  
Standby Trust Agreement and all supporting documentation

Please note while reviewing your financial assurance documents we recently discovered that your package did not include the *specimen certificate of resolution*. Please refer to section A.17 Standby Trust Agreements and checklist 17-A of the NUREG guide mentioned above for further information. There is a model specimen certificate of resolution in A.17.7. Please be sure to include an **unexecuted draft** of the specimen certificate of resolution with your updated DFP.

As per my email note and phone conversation with you on May 23, 2005, you agreed to get back to me within a week as to your plans and schedule to update the DFP. I would appreciate hearing from you as soon as possible regarding this. As always if you have any questions please contact me.
