Gentlemen:

The University of Pittsburgh requests two changes to our license.

1. We wish to relocate our Shepherd model 143-45A irradiator, currently located in 3343 Forbes Avenue. The unit will be moved to the Cellomics Building, 100 Technology Drive, Pittsburgh, PA 15219. The Environmental and Occupational Health department is scheduled to begin moving the end of July, 2005. The removal, packing for shipment and reinstallation of the irradiator will be performed by J. L. Shepherd & Associates.
2. We are purchasing a new J. L. Shepherd Mark 1 model 68 irradiator, SS&D CA0598D104S, to be loaded with 4000 Ci of Cs-137 in a model 6810 source, SS&D CA0598S119S. The unit will be located in a new main campus research building, the Biomedical Science Tower 3, located at 3501 Fifth Ave, Pittsburgh PA 15213. Installation will be performed by J. L. Shepherd & Associates. This unit is tentatively due to arrive in August 2005.

Please amend our license to reflect these changes.
