 - (2) Leak test sample collection.
 - (3) Instruction of customers.
 - (4) Preparation and packaging for the purpose of transportation, disposal, or relocation of devices containing the sealed sources, that have been registered either with the U.S. Nuclear Regulatory Commission under 10 CFR 32.210 or with an Agreement State.
- M. Analysis of leak test and environmental samples as a service for other persons as defined in 10 CFR 20.1003.

CONDITIONS

10. A. Licensed material listed in Items 6.A. through 6.L. may be used at temporary job sites of the licensee anywhere in the United States where the U.S. Nuclear Regulatory Commission maintains jurisdiction for regulating the use of licensed material.
