Thank you for your timely response. The current Pharmalogic Totowa NRC license should/will remain intact as a separate distinct NRC site license.

Here is a follow up on your questions send to Pharmalogic August 18, 2005.

a. Provide a complete description of the transaction (transfer of stocks or assets, or merger).

The buyout agreement is specifically between Pharmalogic and IBA. Ownership buyout – 100% stock takeover. The Pharmalogic LLC entity will not immediately merged into Eastern Isotopes – but will remain separate - held by Eastern's parent company - IBA Radioisotopes Inc.

b. Indicate whether the name has changed and include the new name. Include the name and telephone number of a license contact who NRC may contact if more information is needed if it is not Gregory Hisel, CHP after August 31, 2005.

The name will be (pending final closing and both parties approvals) *Pharmalogic P.E.T. Services of New Jersey, L.L.C. dba Eastern Isotopes*.

If the buyout occurs, the point of contact information will change to Joe Harless.

d. Describe any changes in the organization, location, facilities, equipment or procedures that relate to the license program.

The immediate site's operational organizational structure will remain in place. The RSO listed on NRC license #29-30789-01, Greg Hisel, will remain the same.

dba Eastern Isotopes – Eastern's management team, located in Sterling Virginia, will (re)delegate in writing to the site Totowa site RSO his duties and responsibilities as well as Management's support of his Radiation Safety Program (NUREG 1556 Vol. 13, format).

Pharmalogic P.E.T. Services of New Jersey, L.L.C. – stock instead of being held by *Pelican Holding* – will be 100 % held by *IBA Radioisotopes, Inc.*

e. Describe the status of the surveillance program (surveys, wipe tests, quality control) at the present time and the expected status at the time that control is to be transferred.

Remains the same – Scaled Source Inventory and Wipe Tests will be performed as per the current NRC license.

f. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to the NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.

So confirmed that all records concerning the safe and effective decommissioning of the facility will be so transferred.

g. Confirm that the transferee will abide by all constraints, conditions, requirements and commitments of the transferor or that the transferee will submit a complete description of the proposed license program.

IBA Radioisotopes – Eastern Isotopes – will abide by all constraints, conditions, requirements and commitments of the Pharmalogic NRC license and Radiation Safety Program.
