Summary:	<p>Licensee's renewal application (NRC Form 313) was not signed and the individual's title was also not specified. Additionally, the location of use is not the same as listed on the current license. I called the licensee to discuss this and to request a signed application and to remind that the signatory must be a member of management.</p> <p>The receptionist told me that Mr. Tate will not be in office until next week. She confirmed that he is a member of management (Geologist) of the company. She stated that she will have him send another application. I gave her fax number and the control number</p> <p>On August 25, Mr. Tate called and I discussed with him the deficiencies in the application and guided him through the NRC web site to get NUREG 1556, Vol. 1, Rev. 1, and explained to him the application completion process. He will fax a new application and have the NRC Form 313 signed by the President. He also confirmed that they have not had any other types of gauges except Model 3411-B. (Item 9 of the current license authorizes possession of other models also)</p>
