

Please put pressure on the NRC to conduct a thorough study of the request to allow Entergy Nuclear to increase its output by 20%

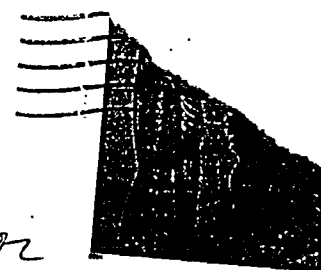
