3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on December 12, 2004. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about December 21, 2004. The containers will then be loaded onto the rail for importation to Port Huron, MI. The containers will enter the USA at Port Huron, MI on or about December 30, 2004, and will continue on rail to Chicago, IL.
