This is to confirm your telephone conversation on August 29, 2005 with Dennis Lawyer in which was discussed the information needed to continue review of your application dated June 8, 2005. The items discussed are specified below.

1. Trinity College has a limited scope license and the Radiation Safety Officer is not authorized to approve authorized users. Please provide the name of each proposed authorized user, with the types and quantities of licensed material to be used. Also provide information demonstrating that each proposed authorized user is qualified by training and experience to use the requested licensed materials. You may wish to refer to NUREG-1556 Volume 7, Consolidated Guidance About Materials Licenses.
2. Please confirm that the Jacobs Life Science Building is the only building where licensed radioactive material was ever used or stored under NRC license 06-09045-03. Please confirm the proper name of the building.
