I write to inquire about the status of the Buy American report that you were required to submit to Congress by March 31, 2005, under section 645 of Division F of the fiscal year 2004 Consolidated Appropriations Act (Public Law 108-199). As you may know, this report is required to include information about any purchases of foreign goods made by your agency during fiscal year 2004. I also request an update on your efforts to make this report publicly available, as it required by Public Law 108-199.

I would appreciate it if you would forward copies of this report to the Senate Transportation, Treasury, Housing and Urban Development, the Judiciary, the District of Columbia, and Independent Agencies Appropriations Subcommittee, to the House Transportation, Treasury, and Housing and Urban Development, the Judiciary, District of Columbia, and Independent Agencies Appropriations Subcommittee, and to me at the earliest possible date.

In addition, I would like to call to your attention the provisions of section 641 of Division H of the fiscal year 2005 Consolidated Appropriations Act (Public Law 108-447), which requires the submission of a similar report for purchases made during fiscal year 2005, which is to be submitted by March 31, 2006.
