According to Mr. Hasegawa, material as UF₆ was delivered to Gulf for conversion to metal and for transfer to Japan for fabrication of fuel elements. Gulf applied for export licenses, showing the fuel fabricator as the consignee. The USAEC delayed issuance of the export licenses because of internal AEC discussions on the necessity for an end use statement from the "ultimate" consignee, the reactor operator. The delay in issuing the export license has caused delay in payment from the Japanese side because they must show the Japanese Government that customs clearance documents have been obtained in order to obtain release of funds.

Hasegawa requests our consideration for the waiver of interest penalties for the time of delay in obtaining export licenses which was occasioned by the USAEC change in the requirements for license applications.

Moore called Bob Miller, Gulf United Nuclear, Hematite, to ask information on the dates the material was picked up from OROO, the dates application for export license were made, other dates when AEC Regulatory requested additional information under the changed license application requirements and the dates licenses were finally issued.

Miller confirmed that applications were first made in July and that the first license (XSNM-447) was dated November 5, 1973. Regulatory requirements and changes thereto caused much of the delay. Miller will give me an up-date.
