<p>Summary:</p> <p>Based on information provided by Diane Dandois of NRC HQ, I contacted Dr. Gualtieri about the licensee's operations. Dr. Gualtieri indicated that the licensee is in the process of going out of business. He believed that operations ceased in mid-July to August 2005. Peter Lieto, nuclear medicine technologist, has been working with a consultant and would get back in touch with me. Dr. Gualtieri mentioned that he had received a packet from the NRC which I asked him to open. The package contained the FY2005 annual invoice. I informed Dr. Gualtieri that the invoice must be paid because it is based on the possession of a license rather than the lack of licensed activities.</p> <p>14:45 Mr. Lieto called to provide additional information. He stated that the last patient study was performed on June 30, 2005. Close-out surveys and transfer of sealed sources have been completed for the Galloway facility and Atlantic Medical Imaging is anticipating a move into the facility. I informed Mr. Lieto that the NRC must issue an amendment to the license releasing the facility for unrestricted use prior to another entity, including the landlord, gains unrestricted access to the facility. Mr. Lieto stated that an amendment request would be sent in but that the Somers Point facility still has sources on-site awaiting removal.</p>
