The purpose of this modification is to provide incremental funding in the amount of \$120,000.00, thereby increasing the total amount of funds obligated from \$242,123.40 to \$362,123.40. Accordingly, the contract is modified as follows:

"(a) The total estimated price of this contract for the products/services ordered, delivered, and accepted under this contract is \$735,820.20.

(b) The amount presently obligated with respect to this contract is \$362,123.40"
