The purpose of this modification is to: (1) exercise CLIN 0002 in accordance with Section I.3, and (2) provide incremental funding in the amount of \$15,500 for delivery orders. Accordingly, the contract is hereby modified as follows:

1. Under Section B.2, Consideration and Obligation—Firm Fixed Price (JUN 1988), the second paragraph is revised as follows:

"The firm fixed price for CLIN 2 is \$14,500. CLIN 2 is fully funded in the amount of \$14,500."

2. Under Section B.3, Consideration and Obligation—Delivery Orders, the first sentence of paragraph (b) is revised as follows:

"(b) The amount presently obligated with respect to this contract for delivery orders is \$108,000."

All other terms and conditions remain unchanged.

A summary of obligations, from the award date through the date of this modification, are provided below:

FY 04 Obligations: \$113,000.00
FY 05 Obligations: \$ 30,000.00

Cumulative Obligations: \$143,000.00

This modification obligates FY 05 funds in the amount of \$30,000.
