Rules and Directives Bran Nuclear Regulatory Commission:

I am writing to OPPOSE Entergy's application for an Early Site Permit (ESP) at the Grand Gulf nuclear plant in Claiborne County, Mississippi.

My main concern on Nuclear power is that we have not found a suitable way to dispose of the nuclear waste created during the making of electricity. Currently we are using dump sites that are not secure and the porposal to use the Yucca Mountain Nevada site is unacceptable because it is so far from all of the Nuclear plants that it would pose a hazard to peoples in the many states through which the waste would have to travel to dump in NV, to say nothing of the environmental impact in the immediate surrounding area to the dump site.
