As requested per letter of September 12, 2005, signed by Timothy I. Mitchell, LifeNet's Vice President of Quality and Compliance, I am contacting you for additional information.

I have the following questions:

1) Please state that materials possessed at the 1457 Miller Store Road, Suite 105, Virginia Beach, Virginia location under license 45-25601-01 have been transferred to your new facility, transferred to an authorized licensee (give information of what was transferred to whom and the licensee number with receipt proof), or properly disposed and the method of disposal.

2.State that the hoods in the RAM laboratory were not used for licensed radioactive material or provide wipe surveys in the hoods.

The following questions are needed for the environmental assessment:

3. What date did licensed operations stop at the facility at 1457 Miller Store Road, Suite 105, Virginia Beach, Virginia?

4. What is the size of the "area of licensed material usage" (as stated on Attachment C of the Decommissioning Survey Report") at 1457 Miller Store Road in square feet?

5. Give a describe of the type of building use, such as "general office and laboratory."

6. Give a description of surrounding area around this building such as, residential, commercial, industrial, mixed residential commercial, etc.

7. Describe the type of activities performed under this license, such as laboratory procedures typically performed on bench tops and in hoods.

8. What is the name of the facility located at 1457 Miller Store Road, Suite 105, Virginia Beach, Virginia? (What did the licensee call this facility?)

Please note that this action was a request to expedite and needs a reply early this week to meet the expected deadline.

Please note that you may not reply to this letter by return e-mail. Your reply must be in writing by letter or facsimile (610-337-5269). If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your amendment.
