ORDER

On July 1, 2004, the Nuclear Regulatory Commission ("NRC") published in the *Federal Register* a notice of opportunity to request a hearing in connection with the pending application for a license amendment submitted by Entergy Nuclear Vermont Yankee L.L.C. and Entergy Nuclear Operations, Inc. ("Licensees") to increase the maximum authorized power level for operation of the Vermont Yankee Nuclear Power Station ("Vermont Yankee"). See 69 Fed. Reg. 39976 (July 1, 2004). The notice specified that any request for a hearing must be filed within sixty days of the date of its publication -- i.e. by August 30, 2004 (August 29 falling on a Sunday).

On August 6, 2004, the NRC published notice that said beginning August 9, 2004, the NRC would begin a three-week engineering assessment inspection ("engineering inspection") of Vermont Yankee as a pilot program to improve the effectiveness of the Reactor Oversight

Process. On the same day, the NRC received a letter from the Governor of the State of Vermont and a letter from Vermont's three members of Congress supporting the Governor's request for an extension of the deadline to request a hearing on the Licensees' application "for a reasonable time beyond the completion of" the engineering inspection "to have the findings available before the deadline to request a formal hearing."

Pursuant to my authority under 10.C.F.R. §2.346(b), the request for an extension of time is denied. Hearing requests are to focus on the information submitted by the licensee in its application to the Commission, or otherwise available at the time the petition is to be filed. 10 C.F.R. 2.309(f)(2).¹ An extension of time will not be granted to allow potential participants to review the results of ongoing staff license review-related activities before filing their hearing requests and accompanying contentions. See *Baltimore Gas & Elec. Co. (Calvert Cliffs Nuclear Power Plant, Units 1 and 2)*, LBP-98-26, 48 NRC 232, 242-43 (1998), *aff'd*, CLI-98-25, 48 NRC 325, 350-51 (1998), *pet. for review denied sub nom. National Whistleblower Center v. NRC*, 208 F.3d 256 (D.C. Cir. 2000). If the engineering inspection "raises a legitimate question

about the adequacy of the application, the petitioner is free to posit that issue as a new or amended contention, subject to complying with the late-filing standards...." *See id.*, 48 NRC at 243.²

² Under the NRC's Rules of Practice, "contentions may be amended or new contentions filed after the initial filing only with leave of the presiding officer upon a showing that --

(i) The information upon which the amended contention is based was not previously available;

(ii) The information upon which the amended or new contention is based is materially different than information previously available; and

(iii) The amended or new contention has been submitted in a timely fashion based on the availability of the subsequent information." 10 CFR § 2.309(f)(2).
