This confirms your telephone conversation with Ms. Mary Jean Pool of my staff on September 20, 2005, in which you clarified your request for a list of licensees in the zip codes you identified in your letter. Attached is a list of all NRC licensees with locations of use in Frederick, Maryland. The license documents do not specifically permit or prohibit discharges into sanitary sewerage because the requirements for discharging radioactive materials into sanitary sewerage are described in Title 10 of the Code of Federal Regulations, Part 20, Section 20.03, a copy of which is attached. Any licensee can discharge radioactive material into sanitary sewerage if they do so in accordance with 10 CFR 20.2003.
