Dear Federal Preservation Specialist:

The American Cultural Resources Association (ACRA) is celebrating its Tenth Anniversary in the city where we began, Washington D.C. on November 11, 2005. ACRA is the national trade association of private sector cultural resource consulting firms. Our mission is to promote the professional, ethical and business practices of the cultural resources industry, including all of its affiliated disciplines, for the benefit of the resources, the public, and the members of the association.

We sponsor a listserv you may have heard about, ACRA-L; and since our inception in 1995, we have been active in supporting legislation and regulations that have protected and enhanced the Advisory Council on Historic Preservation and Section 106 of the National Historic Preservation Act, among other activities. This spring and summer for example, ACRA took the lead in working closely with Preservation Action, the National Trust, SHA, SAA, and NCSHPO and attended hearings and meetings of the Advisory Council on Historic Preservation and the Department of Interior on Capitol Hill and elsewhere in support of Section 106. A delegation of ACRA members visited Washington and lobbied the members of the House Subcommittee on Parks where amendments to the act were being contemplated, and we started and supported a fax campaign by our members and members of state archaeological and professional societies to let the subcommittee know how we felt about the recently proposed amendments.

One of the reasons we are holding our meeting in Washington is so that federal preservation specialists can have the opportunity to learn about us and what we are doing. To that end we are offering a greatly reduced one day registration fee for federal employees to attend our meeting on Friday, November 11. The accompanying program gives you an idea of what we have planned. Registration includes lunch at the Monaco Hotel. Access by metro is easy and convenient.


