This letter and the enclosed NRC Form 591M refer to the inspection conducted on August 8-9, 2005, and a temporary job site inspection at 13735 Missouri Avenue in Nampa, Idaho. The inspections were an examination of activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspections consisted of selected examinations of procedures and representative records, and interviews with personnel.
