Dear Dr. Lamb:

This refers to the letter dated June 30, 2005, informing the NRC of the transfer of ownership and control of NRC Byproduct Material License No. 13-25945-01. Based upon our review of this letter and the additional information submitted in the attachment to this letter, the NRC consents to the change of ownership transaction as stated. As no changes to the NRC license were requested at this time, we are voiding control number 314599 for the letter dated June 30, 2005, and no license amendment is necessary.

As a point of clarification, however, please note that records important to decommissioning must be transferred to the new owner on the transaction date, even though "no decommissioning is required at this time," as stated in the above letter. The records important to decommissioning are described in section 8.7, Item 5 in NUREG 1556, Vol. 9, Rev. 1. All licensees must maintain such records and a review of this section will best illustrate the reason why this is true, i.e., such records are typically the records you already maintain showing receipt, use, storage and disposal of licensed materials, among other things. A copy of NUREG 1556, Vol. 9, Rev. 1, should already have been sent to you and is available on our website at <http://www.nrc.gov>.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). The NRC's document system is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
