3) Transportation and Route Schedule

The vessel sailed from Adelaide, Australia on October 12, 2003. The ocean transportation from Adelaide, Australia to Vancouver, British Columbia, Canada will be the responsibility of P&O Nedlloyd Steamship Line.
