- August 2004 - Perry entered the NRC Action Matrix Multiple/ Repetitive Degraded Cornerstone Column
- January 2005 - IP 95003 Supplemental Inspection Started
- May 2005 - Public Exit Meeting of IP 95003 Inspection Results
- July 2005 - IP 95003 Inspection Report Issued (05000440/2005003)
- August 2005 - FENOC Response to IP 95003 Inspection Issues
- September 2005 - NRC Issues Confirmatory Action Letter
