


- 1.) Stonewall Jackson Hospital has become an affiliate of Carilion Health System effective July 1, 2005. As of October 1, 2005, the name of the facility will be changed to Carilion Stonewall Jackson Hospital. There is no change of control at this time. - 2.) At this time all personnel included in our licensed program; authorized users and the Radiation Safety Officer, will all remain the same.
- 3.) At this time, the licensed program organization, location, facility, equipment, and procedures will all remain the same. Please change our mailing address from "Spotswood Drive" to "1 Health Circle."
- 4.) All surveys, wipe tests and quality control on all equipment are current and will continue to be performed as normal.
- 5.) No facility will be decommissioned at this time.
- 6.) Carilion Health System has several licensed facilities throughout Virginia, which also abide by all constraints, conditions, requirements and commitments of each hospital's licensed program before affiliation with Carilion Health System. At this time, we anticipate no changes in the program.
