This letter and the enclosed NRC Form 591M refer to the inspection conducted on August 10-12, 2005, at your facility located in Boise, Idaho. This inspection was an examination of activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. In addition, an inspection at a temporary job site inspection was performed outside of Boise at a Chevron pipe line. Within these areas, the inspections consisted of selected examination of procedures and representative records, and interviews with personnel. The inspection findings were discussed with Jennifer Haney of your staff at the conclusion of the inspection. A final telephonic exit was conducted with you on October 18, 2005.

Within the scope of this inspection no violations or deviations were identified; therefore, no response to this letter or the enclosed NRC Form 591M is required.
