This letter and the enclosed NRC Form 591M refer to the inspections conducted on August 10, 2005, at temporary job sites at Saint Luke's Regional Medical Center in Meridian and Boise, Idaho. These inspections were an examination of activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, and interviews with personnel. The inspection findings were discussed with Elton Wardlaw at the conclusion of the inspection. A final telephonic exit was conducted with you on October 13, 2005.
