Entergy Nuclear Operations (ENO) was requested to respond to Reference 1 and to implement appropriate enhancements to current mitigation strategies by August 31, 2005. ENO responded, Reference 2, utilizing the guidance developed and issued by the Nuclear Energy Institute ("NEI"), in conjunction with the NEI Security Working Group, for licensee use.

On August 22, 2005 ENO received a request for additional information (RAI) (Reference 3) via encrypted e-mail, regarding our submittal of May 31, 2005. As requested a secure telephone conference was scheduled with the staff. Pursuant to the NRC request during that telephone conference we are providing written responses to each of the questions contained in the NRC RAI.


