The purpose of this modification is to increase the Maximum Ordering Limitation (MOL). Accordingly, the MOL is hereby increased by \$448,044 from \$2,800,276 to \$3,248,320. The contract is modified as follows:

Section B.3, CONSIDERATION AND OBLIGATION – TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991), paragraph (a) is deleted in its entirety and the following is substituted in lieu thereof:

- a. The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$3,248,320.00. The Contracting Officer may place orders with the Contractor during the contract period provided the aggregate amount of the orders does not exceed the MOL.

As a result of this modification, the ceiling amount is increased to \$3,248,320.00. All other terms and conditions remain the same.

This modification does not obligate any FY05 funds.
