

The purpose of this modification is to de-obligate FY'05 funds in the amount of \$70,000.00, thereby decreasing the obligated amount of the subject contract from 1,655,000.00 to \$1,585,000.00. This modification hereby incorporates by reference, the September 26, 2005, e-mail from James Ruland, President, Ruland Associates, Inc., in which Ruland agrees with the de-obligation of funds.

Accordingly, the following changes are hereby made:

Subsection B.24 CONSIDERATION AND OBLIGATION, is deleted in its entirety and substituted with the following in lieu:

"CONSIDERATION AND OBLIGATION

- a. The total estimated cost to the Government fo full performance under this contract is \$2,103,512.00.
- b. The amount currently obligated by the Government with respect to this contract is \$1,585,000.00.
- c. It is estimated that the amount currently allotted will cover performance through November 30, 2005.
