The purpose of this modification is to replace the following hands-on exercises specified in Attachment 1, Statement of Work, to the subject contract, Paragraph C.1, of the EDG course: 1. Start up Activities; 2. Loading the electrical generator, including parallel operations with an electrical system; 3. Shutdown and post-operation activities; and 4. Routine Maintenance. The exercises are to be replaced with a hands-on tour of the Fairbanks-Morse factory in accordance with the contractor's letter dated 8/1/05 (see Attachment 1 to this modification). The contractor is to provide, at no additional cost to NRC, either alternate replacement Option 4a OR Option 4b. A summary of obligations for this contract is as follows: Total FY 2005 Obligation.....\$67,378; Cumulative Total of NRC Obligation.....\$67,378.
