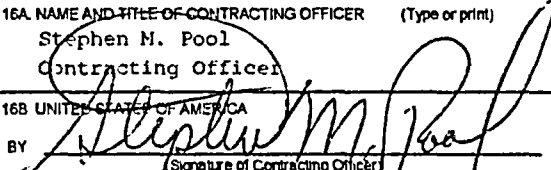
The purpose of this Modification is to de-obligate funds in the amount of \$256,568.74. See page 2 for Call No. details.
