


Per the Contracting Officer's verbal authorization on 09/01/2005, the purpose of this modification is to (1) incorporate the within-scope work in accordance with the attached SOW (Attachment 1) for Task Order No. 2 under the subject contract; (2) extend the period of performance of the task order through 9/23/06; (3) obligate incremental funds in the amount of \$100,000.00 for the task order; and (4) increase the obligated ceiling amount of the task order by \$100,000.00, from \$108,706.70 to \$208,706.70.
