Dear Administrative Judges:

In its Initial Scheduling Order dated January 19, 2005, the Atomic Safety and Licensing Board presiding over this proceeding ordered the NRC staff to notify the Board and parties of any delay and revised schedule "within 10 days of any changes or revisions in the estimates for completion or issuance of the FEIS, FSER, NUREG, or ACRS letter." The Staff had previously informed the Board of changes to the Staff's review schedule in letters dated July 8, 2004, November 12, 2004, and August 19, 2005.

Pursuant to the Board's Initial Scheduling Order, the Staff hereby informs the Board and parties that the schedule for issuing the final EIS has changed in light of a letter dated October 24, 2005, from Dominion to the Staff. In the letter, which is enclosed, Dominion has informed the Staff that it intends to modify the cooling system proposed for ESP Unit 3. This modification will warrant a change in the final EIS.

In a letter dated November 2, 2005, the Staff requested that Dominion revise its application and environmental report (ER) to describe this new proposal and its effects, and submit a schedule for doing so. Until the Staff receives and considers the revised application and ER, the Staff is unable to project when the final EIS can be issued. In addition, the safety evaluation report (SER), NUREG-1835, issued September 2005, may need to be supplemented in light of the revision to the application.

**NORTH ANNA EARLY SITE PERMIT APPLICATION**  
**PLANNED REVISION TO UNIT 3 COOLING WATER APPROACH**


Dominion Nuclear North Anna, LLC (Dominion) has conducted additional evaluations of cooling water alternatives for a potential third nuclear reactor at its North Anna site. Based on those evaluations, the company has decided to modify its approach for cooling a third unit from the base case currently described in the North Anna Early Site Permit application. The revised approach would reduce both thermal impacts and water consumption associated with Lake Anna. The company is taking this action partly in response to concerns that have been raised by state regulatory bodies and local residents.

Under the revised approach, Unit 3 would use a closed-cycle cooling system that would not utilize the 3,400-acre waste heat treatment facility for cooling. In addition, the evaporative loss of water from Lake Anna required for cooling a third unit would be reduced from that previously considered.

We are currently evaluating the potential impact of this revised approach on the North Anna ESP application and will take appropriate action based on the results of that evaluation. However, it was deemed prudent to advise you of our decision in a timely manner so that you would be aware of this change in plans.

SUBJECT: MODIFICATION OF THE COOLING SYSTEM FOR DOMINION NUCLEAR  
NORTH ANNA ESP SITE

Dear Mr. Christian:

By letter dated October 24, 2005, Dominion Nuclear North Anna LLC (Dominion) notified the Nuclear Regulatory Commission (NRC) of Dominion's intent to modify its approach for cooling a potential third unit from the once-through cooling system currently described in the North Anna Early Site Permit (ESP) application. In your letter, you stated that this modified approach would use a closed-cycle cooling system that will not utilize the 3,400-acre waste heat treatment facility for cooling. In addition, you stated that the evaporative loss of water from Lake Anna necessary for cooling a third unit will be reduced from that previously considered.

The staff requests that Dominion submit a revision to the ESP application and environmental report to more specifically describe the proposed changed cooling system, with a discussion of the associated environmental and safety impacts in all affected areas. Please provide a schedule for submitting a revision to the application within 14 days of receipt of this letter such that the staff can accurately assess the resources and schedule impacts of the proposed change.

The staff will evaluate Dominion's revised submission to determine if changes to the environmental impact statement (EIS) and the safety evaluation report (SER) are warranted, and will inform you of the new schedule for issuing the EIS.
