The NRC staff held a conference call with Mr. Ray Baker and Ms. Cynthia Tully of the Southern Nuclear Operating Company, Inc., on November 4, 2005. The purpose of the call was to discuss scheduler information concerning testing to be performed in accordance with Generic Letter 2003-01, "Control Room Habitability." The NRC staff requested the scheduler information in a letter dated September 7, 2005. As a result of the discussion, the NRC staff requested additional information regarding the testing of the control room envelope. The NRC staff agreed that the response could be delayed until November 14, 2005, to allow sufficient time for the licensee to update the letter and obtain the appropriate management concurrences.

The NRC staff notes that the licensee recommended that a public meeting on this issue, originally planned for November 29, 2005, should not be cancelled as a result of the information exchanged during the conference call. The NRC staff agreed to hold the meeting as planned.
