Dr. Javed Rana,

I wanted to follow up our phone conversation with an email detailing what additional information I need to process the new license application for Javed Cardiac Center, PLLC.

Regarding your request to name yourself as RSO to the new license, additional information is necessary. As we discussed, please refer to 10 CFR 35.50 Training for Radiation Safety Officer. The NRC regulations are available through a link at our web site, www.nrc.gov. Since we will be naming you as an authorized user on the new license you can look specifically at 10 CFR 35.50(c)(2). I will need a letter from the RSO for the Bluefield Regional Medical Center license, attesting that you have satisfactorily completed the requirements in paragraph (e) of 10 CFR 35.50. The letter should state that you have had training, supervised by either the RSO, medical physicist, nuclear pharmacist or an authorized user, in the radiation safety, regulatory issues and emergency procedures for 35.100 and 35.200 uses of licensed material. The letter should also state that you have achieved a level of radiation safety knowledge sufficient to function independently as a radiation safety officer for a 35.100 and 35.200 licensee.

I will continue my review of your renewal application upon receipt of this information. In order to continue a timely review of your renewal application I request that you submit your response within thirty days.
