Summary of Actions Taken
Response to NRC Order EA-04-103

I. INTRODUCTION

The Nuclear Regulatory Commission's letter of April 27, 2005, issued Confirmatory Order EA-04-103 to SCI. Section IV of the Confirmatory Order Modified License Number 45-15200-04 currently held by SCI. To comply with the requirements of the license modifications, SCI has agreed to and has taken the following actions listed below:

1. **The licensee shall hire an outside consultant to: a) Provide insight and develop an initial training module addressing a Safety Conscious Work Environment (SCWE) and 10 CFR 30.7, Employee protection, "by no later than five months from the date of issuance of the Confirmatory Order, b) Conduct initial training for managers and employees of SCI using the module by no later than six months from the date of issuance of the Confirmatory Order, c) Develop a refresher training module addressing SCWE and 10 CFR 30.7 for the managers and employees of SCI by no later than six months from the date of issuance of the Confirmatory Order.**

Actions taken by SCI

Outside Consultants were hired by SCI to provide insight and development of an initial training module addressing a Safety Conscious Work Environment (SCWE) and 10 CFR 30.7 Employee Protection (See enclosure 3).

On September 20th and 21st 2005, the outside consultants administered the initial learning modules to support personnel and technicians and then to the managerial staff at all levels.

Development of the refresher training modules for managers and employees addressing SCWE and 10 CFR 30.7, Employee Protection, has been provided by the outside consultants and is available for our use, as per the contract agreement with the outside consultants and SCI.

2. **The licensee shall revise its training program requirements to conduct refresher training of SCWE and 10 CFR 30.7 at a frequency consistent with SCI's general employee training, by no later than six months from the date of issuance of the Confirmatory Order.**

Actions taken by SCI

Development of a monthly calendar reflecting SCI's Training Program has been posted. It includes allocated time and dates to conduct SCWE and 10 CFR 30.7 Employee Protection training for all SCI Employees and will include fresher training for all employees and managers in March of 2006. (See enclosure 5).

3. **By no later than six months from the date of issuance of the Confirmatory Order, the licensee shall revise its training program requirements to conduct SCWE and 10 CFR 30.7 training for new managers and employees of SCI, within sixty days of their assumption of duties.**

Actions taken by SCI

Development of a Monthly Calendar reflecting SCI's training program has been posted and includes allocated time and dates to conduct SCWE and 10 CFR Employee Protection for all new employees within sixty days of their assumption of duties. This includes all administrative support, technicians and management.

4. **The licensee must pay a civil penalty in the amount of \$1,200.00 for a violation of 10 CFR 30.7, "Employee Protection", requirements within thirty days of the date of issuance of the Confirmatory Order.**

Actions taken by SCI

On April 28th, 2005, SCI issued check number 56425 in the amount of \$1200.00 to the U. S. Nuclear Regulatory Commission and was posted to the M & T Bank of Baltimore on May 11th, 2005 (See enclosure 4).
