Received a call from Joyce Stowell [REDACTED] a concerned citizen living in Greenfield, MA about 20 miles from Vermont Yankee. She feels that all nuclear plants are unsafe and should be shutdown; that there is no safe way to dispose of nuclear waste;; that we are not conserving energy resources; etc, etc. 646

She read a letter to the editor stating that the NRC did not facilitate the Vermont Yankee public meeting on power uprate of 3/31/04 in a manner that was responsive to people's concerns.

She stated that she heard a rumor from a colleague that Entergy is raiding VY's decommissioning fund for use on the VY power uprate.
